



Robina Floors Bamboo Warranty

Limited Warranty for Bamboo Flooring

This warranty applies to Robina Floors Inc. bamboo flooring brands installed in buildings. We want you to be happy and confident in your investment. Since its inception, Robina Floors Inc. has been committed to providing only the finest flooring products in the market. Our superior design, production technologies and style allow us to provide one of the best warranties in the industry subject only to a few common sense exclusions.

Warranties

For all of our bamboo flooring, Robina Floors Inc. makes the following Structural Warranty.

1 Structural Warranty;

This Warranty extends to the first owner of the structure in which the Flooring is installed. Robina Floors Inc. warrants that the bamboo flooring sold under this Warranty (the "Flooring") is, at the time of sale, free from defects in material and manufacture and that it conforms to Robina Floors Inc.'s standard specifications for the flooring model. Under the Limited Structural Warranty, Robina Floors Inc. further warrants that when maintained according to Robina Floors Inc. guidelines and used for its intended purpose, the Flooring will not delaminate, separate, buckle or cup as a result of manufacturing defect during this Warranty period (see chart below).

2 Finish Warranty;

This Warranty extends to the first owner of the structure in which the Flooring is installed. Robina Floors Inc. warrants that the factory-installed finish on the Flooring is, at the time of sale, free of defects in material and manufacture and that it conforms to Robina Floors Inc.'s standard specifications for the finish. Robina Floors Inc. further warrants that when the Flooring is maintained according to Robina Floors Inc. instructions and used for its intended purpose, the finish will not wear through to the underlying Flooring or separate from the Flooring as a result of a manufacturing defect for set number of years (see chart below) from the date of sale (the "Finish Warranty Period"). This warranty does not cover scratches, reduction in the shine of the finish, minor imperfections and irregularities (up to 5%) or damage to the finish caused by damage to the underlying Flooring.

The Robina Floors Inc. maintenance instructions **MUST** be followed as a condition for these Warranties to have effect. You may obtain these instructions from your local dealer. This Warranty does not cover damage or defects resulting from or in any way attributable to:



1. Improper storage, handling or installation of the Flooring (including improper installation of joists and subflooring or improper surface preparation);
2. Abuse, lack of maintenance, neglect, abnormal use or misuse, negligence, application of solvents, corrosives or other chemicals to the Flooring, color change, fading or damage due to exposure to the sun, crazing, excessive pivot and point-loads, spike-heeled shoes, unpadded furniture feet, water, damage from sand, pebbles or other abrasives or other unintended uses;
3. Insect infestation after shipment from the point of origin;
4. Stains and finishes;
5. Improper alterations of original manufactured product;
6. Moisture problems (including subfloor moisture, leaks, rain, wet mopping, etc.) or excessive dryness or heat;
7. Settlement or movement of the structure to which the Flooring is attached;
8. Natural events such as hurricanes, tornadoes, earthquakes, and floods;
9. Variations in color, grain and markings that exist in the Flooring when new (such variation in bamboo is a natural occurrence, so that Flooring may not match display samples) or that develop over time because of varying exposure to sunlight or UV light;
10. Installation over radiant floor heating with a surface temperature in excess of 85°F (or temperatures per installation guidelines for specific product); or
11. Installation of Flooring with visible defects.

Disclaimer of Implied Warranties

THE ABOVE WARRANTIES ARE THE EXCLUSIVE AND SOLE WARRANTIES GIVEN BY ROBINA FLOORS INC. FOR THE FLOORING. THEY SUPERSEDE ANY PRIOR, CONTRARY OR ADDITIONAL REPRESENTATIONS, WHETHER ORAL OR WRITTEN. ANY IMPLIED WARRANTIES, INCLUDING THE **WARRANTY OF MERCHANTABILITY, ANY WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE**, ARE LIMITED IN DURATION TO THE WARRANTY PERIODS FOR THE CORRESPONDING EXPRESS WARRANTIES, ABOVE.

Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

What we'll provide if the Flooring is Non-Conforming.

If during the applicable Warranty Period, the Flooring does not conform to the preceding Warranties, the owner of the Flooring shall notify Robina Floors Inc. as provided below, and within a reasonable time Robina Floors Inc. will provide, at its option, one of the following: (1) repair of any nonconforming or defective Flooring (for defects in finish, this means refinishing



the affected planks), (2) provision of conforming planks to replace any nonconforming planks, including a reasonable allowance for associated costs of removal and reinstallation, but this allowance shall be included only during the first two years of use and it does not include the cost of removal of fixtures installed on the Flooring, (3) refund of the purchase price for any nonconforming planks that have not been installed, or (4) refund of the percentage of the purchase price for the non-conforming planks equal to the percentage of the Warranty Period remaining when Robina Floors Inc. is notified of the nonconformity.

THESE REMEDIES SHALL BE THE EXCLUSIVE AND SOLE REMEDIES FOR ANY BREACH OF WARRANTY.

If the Flooring does not conform to the Warranty, the owner of the Flooring must notify Robina Floors Inc. in writing at the address below within thirty (30) days after discovering the nonconformity. The notice must describe the location and nature of the nonconformity. The owner must give Robina Floors Inc. a reasonable opportunity to examine the claimed nonconformity before undertaking any repairs, removal or replacement. The owner must present the original invoice, bill or other proof of the date of purchase. Compliance with the requirements of this paragraph is a condition to coverage under the Warranty: if these requirements are not complied with, Robina Floors Inc. will have no obligation to remedy any nonconformity.

Exclusion of Incidental and Consequential Damages.

IN NO EVENT SHALL ROBINA FLOORS INC. BE LIABLE FOR ANY INCIDENTAL, SPECIAL, INDIRECT OR CONSEQUENTIAL DAMAGES, WHETHER RESULTING FROM NONDELIVERY OR FROM THE USE, MISUSE OR INABILITY TO USE THE PRODUCT OR FROM DEFECTS IN THE PRODUCT OR FROM ROBINA FLOORS INC.'S OWN NEGLIGENCE.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation may not apply to you.

This warranty gives you specific legal rights, and you may also have other rights which vary from State to State.
